The regularly scheduled meeting of the City of Fennville was called to order in City Hall at 7:00 p.m. by Mayor Rastall.

PUBLIC COMMENT: None.

**APPROVAL OF MINUTES: Moved Suerth, second Meyaard to approve the minutes of the May 19, 2008 meeting as printed.** Ayes: All. MOTION CARRIED.

**COMMUNICATIONS:** Reviewed violation letters sent. Discussion with attorney in regards to Mr. VandenHeuvel's request to dump his sewage in the city's lagoon. **Moved Rastall, second Suerth to deny Mr. VandenHeuvel's request to have his sewage dumped in the city's lagoon.** Ayes: All. MOTION CARRIED.

**SPRING CLEAN-UP BID:** Discussion on cost and clean-up. No freon appliances will be picked up. **Moved Morse, second Pantelleria to approve Allied Waste as the company for the spring/summer clean-up.** Ayes: All. MOTION CARRIED.

**SIDEWALK USE PERMIT – DICKINSON: Moved Morse, second Pantelleria to approve the sidewalk permit for Dickinson Hardware.** Ayes: All. MOTION CARRIED.

**FINANCIAL/PERSONNEL REPORT:** Pantelleria reviewed the 2008-2009 fiscal year budget. Salaries include no increase for the city commissioners, and a 3% raise for staff, with no Christmas Bonus for staff. Pantelleria recommends an increase for the sewer/water rates by Oct. 1, 2008. The budget hearing will be held at the next meeting, June 16, 2008.

**CITY SERVICES:** Next fire board meeting will be held July 8<sup>th</sup> at 7:00 p.m.

**CITY PROPERTIES:** Discussion on the softball fields. Cleaning of Paradise Park will be done in July.

**ORDINANCES/COMMUNITY RELATIONS:** Morse stated that the water was off in the cemetery over Memorial Day because of a pump that was burnt out.

**PLANNING COMMISSION REPORT:** Watson reported that there will be copies of the CCOD in your boxes for next meeting.
